Leland Gallup spoke about the upcoming SET event (Simulated Emergency Test 2018) and how he would appreciate it if GARS would cosponsor the event. The board approved to be a cosponsor. The event will take place, October 13<sup>th</sup>, 2018 at 9 AM.
